Further, by affixing my signature below, **I am affirmatively acknowledging the following:** (1) that I have read this agreement, which includes and incorporates the MAHA's Conditions Of Membership, in entirety and fully understand the terms, conditions and agreements herein; (2) that my use and other members use of MAHA properties and facilities may involve the use of guns, bows, boats and other weapons; (3) that hunting is by nature a very **dangerous and potentially hazardous** sport which has inherent risks which include but are not limited to dangers of catastrophic injury, death and property damage; (4) that property provided for use to members by the MAHA and its landowners or tenants may have physical conditions, visible and/or hidden, that can be hazardous to my personal safety and to the safety of family members who fall under my membership; (5) that I have been advised and am now aware that MAHA expressly reserves the right to amend its Conditions Of Membership at its sole discretion and that I am expected and obligated as a condition of my membership to read and comply with MAHA's Conditions Of Membership and its Amendments; (6) that other than to extend members the right to use property for hunting and fishing sports, MAHA makes no additional promises or warranties as to the physical condition of land and/or water on any property provided for member use.
